Web Wanderings

FamilySearch

FamilySearch has added more than 462,000 thousand browsable digital images to its collection "Australia, New South Wales, Cemetery, Military, and Church Record Transcripts, 1816-1982". These are images created from the card file of cemetery transcripts and a few other record sources created by Clarice (Taylor) Cubbins (1916-2014). Most are from New South Wales; however, there are some from elsewhere in Australia and New Guinea. For more information go here.

NSW Court Records

Ancestry has added a collection of historic court records from New South Wales. The 200,000 records span the years from 1830 to 1945 and can be searched by name, location, year and keyword. This collection is primarily of criminal cases. Access is free at the QFHS library or by subscription here.

Post-1996 UK Wills and Grants of Probate

The UK Probate Service has launched an online probate search facility, enabling a search of the probate records for England and Wales from 1996 to the present day. Results show first and surnames, date of probate, probate number, date of death, document type and registry. Copies of the documents are available for £10, paid by debit or credit card and provided within 10 days. The service is working to provide online all 41 million of its records dating back to 1858. More information may be found here. A different process is in place for Scotland (see here) and Northern Ireland (see here).

Essex Ancestors Wills online

The website Essex Ancestors run by the Essex Records Office has uploaded an additional 22,500 historic wills, bringing the total to some 70,000 wills. They span the years from the 1400s to 1720, and work continues to digitise the remaining 28,000 wills of 1720 to 1858. Access is by subscription at their website here or find out more here.

UK Schools and Admission Registers

New UK Schools and Admission registers for Anglesey, Plymouth and West Devon have been added to the Findmypast collection of National School Admission Registers & Log-Books 1870-1914. The Registers allow you to trace your ancestors through their school years and provide information such as the name of the school, name and address of each pupil, date of admission, date of leaving and the names of parents or guardians. Some may also include date of birth, whether parents are living or dead and a parent's occupation. Access is free at the QFHS library or by subscription here.

Prison Ship Registers

Over 4,000 Prison Ship (Hulk) Registers 1811-1843 records have been added to the collection of Crime, Prison and Punishment records. These new records come from six prison hulks; Discovery, Captivity, Antelope, Dromedary, Weymouth and Coromandel and list the details of over 13,300 inmates held on the ships between 1811 and 1843. Entries may include an inmate's name, age and trade as well as details of their crime, sentence and character. Access is free at the QFHS library or by subscription here.

Devon BMD Records online

Findmypast has added extensively to a number of record sets for Devon. Access is free at the QFHS library or by subscription.

- Devon Parish Baptisms 1444-1915 more than 750,000 new records added here. This collection comprises transcripts and colour images of baptisms, scanned from original registers held at the records offices in Devon.
- Devon Parish Banns 1538-1915 more than 164,000 new records added here.
- Devon Parish Marriages 1446-2001 more than 308,585 new records added here.
- Devon Parish Burials 1320-1926 covering most of the Church of England parishes in Devon, contains over a million records <u>here</u>.
- Devon Wills Index 1163-1999 more than 250,000 records proved by 30 courts. See them here.

Limits to Irish BDM Search

Civil registration data, such as births, deaths and marriage registration, was briefly available on the website Irish Genealogy here. After the country's data protection commissioner warned that potentially sensitive personal details were available to all, the Irish government closed part of the site. A compromise has been reached that will allow the release of data limited to births more than 100 years old, marriages more than 75 years old and deaths more than 50 years old. Irish Street Directories online

A new website contains historic Irish street directories and some historic maps of the country. The website also contains a townland database and can be found here. For help with directory abbreviations go here.

Griffith's Survey Maps & Plans 1847-1864

Griffith's Survey Maps & Plans, 1847-1864 contains over 95,000 Ordnance Survey maps and town plans used by the team working on Griffith's Primary Valuation of Ireland. Each record includes a survey transcript and most also contain images of maps and town plans. Unfortunately there are only transcripts for Northern Ireland. Dublin in 1835-45

Pettigrew and Oulton's Dublin Almanac and General Register of Ireland 1835-1845 was the first annual publication to include a street by street directory of Dublin. Not only a street directory but also an alphabetical list of inhabitants, grouped by profession. Find out more here.

Search Historical Newspaper Archives with Elephind

Elephind is a free resource for anyone who wishes to search old newspapers. It makes it possible to search all the world's digital newspapers from one place and at one time. Much like Google or other search engines, it's focused only on historical, digitised newspapers. Clicking on the search result that interests you takes you directly to the newspaper collection that hosts that story. It includes newspapers from the United States, Mexico, Australia, New Zealand, and Singapore amongst others. You can try Elephind here.

The Great Parchment Book of the Honourable the Irish Society

How Many Irishmen Died in the First World War?


The Irish War Memorial Records are to be updated. They presently list the names of 49,400 men who died in WWI, however this includes non-Irish soldiers who died in Irish regiments and exclude many Irishmen who died in non-Irish regiments. There are also many double entries and errors. The records were digitised and released last year and are available here, but after nearly 100 years many of the individual records are flawed or incomplete. The Surname Society Launches

The Surname Society has been founded as a not-for-profit entity by a worldwide group of experienced genealogists. It is an online society focussing on single surname studies, with members registering both worldwide and limited studies. Collaboration is both facilitated and encouraged, as it is the core ethos of the society. The annual cost of membership is £5 which includes a quarterly enewsletter. There are no hidden extras. The Guild of One-Name Studies

This British-based organisation has been in existence since 1979. It currently has over 2,600 members in thirty countries around the world. It provides its members with the means to share, exchange and publish information about one-name studies as well as encouraging and assisting all those interested in one-name studies by means of conference, seminars, projects and other activities. Several popular TV programs of late have featured the midwife. Joan Grundy's book *History's Midwives* shows the development of this role against the background of the development of medical practice. Until the middle of the eighteenth century medicine was under the auspices of church authorities. Licenses were issued primarily to guard against practice by 'ignorant persons' but without requiring training or proof of learning. The medical schools of Oxford and Cambridge stated that it was an occupation degrading to a gentleman, however the role continued to develop. In addition to her medical expertise, a midwife was expected to have the

correct form of baptism for a frail infant, to have her own herb garden for herbs supposed to relieve pain or hasten delivery, and to take control of a household in readiness for birth. In some cases she had to take on a quasi-legal role assisting the parish officer discover the name of the father of an illegitimate who, if not named, would become a charge on the parish. Grundy's book is a short work of 135 pages but it is packed with well-sourced information including birthing practices and the current role of the midwife in the UK. The footnotes are sometimes more informative than the text. If you have a Yorkshire midwife in your family tree you may find her in the C17 and C18 listing. Joan E.
